

Good afternoon,

Would your institution or any of your Student Groups have an interest in hosting a professional public speaker for the very contemporary "hot topic" around the country regarding the marriage debate and . . . polygamy?

On June 26, 2015, the US Supreme Court's *Obergefell v. Hodges*<sup>1</sup> Decision legalized same sex marriage in a way that could ultimately impact polygamy too.<sup>2</sup> My own repeated soundbite<sup>3</sup> from 2006 in *Newsweek*<sup>4</sup> shows how significant the issue has now become:

***"If Heather can have 2 Mommies, why can't she have 2 Mommies and a Daddy?"***<sup>5</sup>

For more relevance, almost 3 years ago in December, 2013, a federal court de-criminalized *de facto* polygamy in Utah<sup>6</sup> and awarded damages to the polygamous family in August, 2014.<sup>7</sup> Although reversed by the US Tenth Circuit Court of Appeals on April 11, 2016<sup>8</sup> (yet not reversed on any *merits*<sup>9</sup>), the case is **now on appeal<sup>10</sup> up to the Supreme Court.**<sup>11</sup> Previously, in December, 2012, *TIME* magazine listed polygamy activism in its Top Ten of current issues regarding marriage.<sup>12</sup> Over the recent few years, a number of reality TV series about polygamists have been aired - including "My Five Wives"<sup>13</sup> (2014), "Polygamy USA"<sup>14</sup> (2013), and "Sister Wives"<sup>15</sup> (2010). Before this decade started, only HBO aired a TV-series on polygamy, called, "Big Love,"<sup>16</sup> (2006) – and that was only fiction.

Preceding all of these, it has been my national leadership for activism since 1994<sup>17</sup> that has been paving the way by which such recent shows could now be possible.<sup>18</sup> Truly, *now*, polygamy has become a contemporary "hot topic" around the country.

Please permit me to introduce myself to you. My name is Mark Henkel - and I am not from Utah. Indeed, I am genuinely unlike anyone else who might speak on this issue.

As a Maine resident from Old Orchard Beach, I am the established<sup>19</sup> National Polygamy Advocate<sup>20</sup> for the National Polygamy Rights Movement for Consenting Adults.<sup>21</sup> As the nation and college campuses around the country discuss the issues of marriage equality, marriage protection, and marriage control,<sup>22</sup> I bring an interesting,<sup>23</sup> intellectual,<sup>24</sup> thought-provoking,<sup>25</sup> win-win,<sup>26</sup> non-Mormon,<sup>27</sup> and non-stereotypical viewpoint to the debate.<sup>28</sup>

Publicly presenting and working for polygamy rights since 1994,<sup>29</sup> I have even been involved in the same sex marriage debate in Maine.<sup>30</sup> A number of Maine-local media<sup>31</sup> have reported about me, including the Portland Press Herald.<sup>32</sup> Nationally, I have been interviewed/reported by hostile,<sup>33</sup> non-hostile,<sup>34</sup> conservative,<sup>35</sup> Christian,<sup>36</sup> liberal,<sup>37</sup> and libertarian<sup>38</sup> media outlets, including numerous major media too,<sup>39</sup> such as FOX Business,<sup>40</sup> ABC's 20/20,<sup>41</sup> *Newsweek*,<sup>42</sup> *The Washington Times*,<sup>43</sup> *USA Today*,<sup>44</sup> and many more. Regarding Academia, I have persuasively refuted the public anti-polygamy biases of American<sup>45</sup> and Canadian<sup>46</sup> Professors,<sup>47</sup> while also having my own political arguments vindicated by a renowned Constitutional Law Professor<sup>48</sup> and other lawyers<sup>49</sup> too. Whether other authors were writing a Masters thesis,<sup>50</sup> a Doctorate dissertation,<sup>51</sup> or simply non-fiction, I have also been cited by name in a number of publications and published books.<sup>52</sup>

My public speaker's "one sheet" has been attached for your review.<sup>53</sup> As a professional speaker on this unique topic, I was asked<sup>54</sup> to present an important<sup>55</sup> keynote speech at Yale University,<sup>56</sup> showing "*WHY You WILL Vote YES to Repeal Anti-Polygamy Laws for Consenting Adults.*"<sup>57</sup> The structure I intentionally designed for this persuasive message enables me to uniquely individualize and re-direct it toward different audiences.<sup>58</sup>

Perhaps the students at your institution could equally benefit from such a public speaking event? I am currently filling my calendar to present such speeches for this coming year and would be glad to arrange to add your institution to the schedule. If that would be too soon for you, however, I will be glad to explore later options as well. Would this be of interest for your institution or any of your Student Groups to consider?
